-- ON THE NIGHT OF FEBRUARY 19, FEDERAL POLICE IN SAO PAULO DETAINED ESQUIVEL FOR 45 MINUTES IN ORDER TO WARN HIM AGAINST COMMENTING ON BRAZILIAN INTERNAL AFFAIRS (REFTEL). HE EMPHASIZED THE UNDESIRABILITY OF ANY MILITARY INTERVENTION IN EL SALVADOR, SPECIFICALLY NAMING THE UNITED STATES. COMMENTING ON THE TRIP OF GENERAL VERNON WALTERS TO SEVERAL LATIN AMERICAN COUNTRIES, ESQUIVEL REPORTEDLY SAID THAT "THE SOLUTION FOR THE PROBLEMS OF ALL OF CENTRAL AMERICAN, AND NOT ONLY EL SALVADOR OR GUATEMALA, MUST BE FOUND THROUGH NEGO-TIATIONS, A POLITICAL RATHER THAN A MILITARY ALTERNATIVE." HE ALSO CIRITICIZED THEUNITED STATES FOR PROVIDING ARMS TO EL SALVADOR.
