B) LILIANA VOGLER. THE FEDERAL COURT OF APPEALS
IN CORDOBA CONFIRMED LILIANA VOGLER'S 9 YEAR
SENTENCE LAST WEEK. APPRECIATE IF DEPT. WOULD INFORM
CONG. MILLER AND VOGLER FAMILY.
