2. THE UNDER SECRETARY'S OPENING REMARKS -----  
MR. NEWSOM STATED THAT HIS VISIT TO ARGENTINA WAS  
TO DEMONSTRATE THE CONTINUING UNITED STATES CONCERN  
REGARDING HUMAN RIGHTS PROBLEMS HERE AND ALSO TO  
DEMONSTRATE THE UNITED STATES INTEREST IN IMPROVING  
RELATIONS WITH ARGENTINA. AS HE WISHED TO OBTAIN  
AN IMPRESSION OF THE PRESENT CIRCUMSTANCES IN  
ARGENTINA, HE COULD NOT LEAVE ARGENTINA BEFORE  
MEETING WITH THOSE FIGHTING FOR HUMAN RIGHTS AND  
LEARNING OF THE PROBLEMS WHICH THEY FACE.

3. MR. NEWSOM SAID THERE ARE TWO ISSUES WHICH CONCERN  
THE UNITED STATES' EXECUTIVE AND CONGRESS. THE FIRST IS  
THE TRAGIC QUESTION OF THE DISAPPEARED. HE REQUESTED  
IMPRESSIONS FROM THE HUMAN RIGHTS ORGANIZATIONS REGARDING  
WHAT IS BEING DONE TO FACILITATE THE SEARCH BY FAMILIES  
FOR THEIR DISAPPEARED RELATIVES. THE SECOND ISSUE  
RELATES TO THOSE BEING HELD UNDER DETENTION. REGARDING

4. INTRODUCTORY STATEMENTS BY HUMAN RIGHTS ORGANIZATIONS --  
MOTHERS OF THE PLAZA DE MAYO: MRS. BONATINI AND MRS.  
PARGAMENT SAID THAT THEY WERE TWO OF THE MOTHERS WHO  
MEET EVERY THURSDAY IN THE PLAZA DE MAYO TO PROTEST  
SILENTLY THE DISAPPEARANCE OF THEIR CHILDREN. THEY  
STAY IN THE PLAZA UNTIL THE POLICE FORCE THEM OUT.  
THEY NOTED THAT THEY ARE STILL DEMONSTRATING  
WEEKLY AND WILL CONTINUE TO SHOW UP IN THE PLAZA UNTIL  
THEY RECEIVE INFORMATION WHETHER THEIR CHILDREN ARE  
ALIVE OR DEAD. MRS. PARGAMENT POINTED OUT THAT THERE  
IS NO PLACE TO OBTAIN INFORMATION REGARDING THE

DISAPPEARED. IN RESPONSE TO A QUESTION, SHE SAID THE MINISTRY OF INTERIOR ROUTINELY SAYS THAT IT HAS NO INFORMATION REGARDING THE DISAPPEARED, AS DO THE POLICE AND THE MILITARY FORCES. THERE ARE ONLY NEGATIVE REPLIES. SHE SAID THAT AT TIMES MOTHERS RECEIVE EXTRA-OFFICIAL INFORMATION THAT THEIR CHILDREN ARE BEING DETAINED IN A POLICE OR MILITARY FACILITY; BUT WHEN THEY GO TO FIND THEIR CHILDREN, THEY ARE TOLD THE CHILDREN ARE NOT THERE.

5. IN RESPONSE TO A QUESTION REGARDING REAPPEARANCES, MRS. PARGAMENT SAID THAT ONLY A FEW APPEAR. MRS. BONAFINI MENTIONED THAT IN HER OWN CASE A FRIEND OF HER SON, WHO WAS CHARGED WITH STEALING, WAS RELEASED AFTER HAVING SPENT THREE MONTHS IN AN UNDERGROUND PLACE (POZO) WITH HER SON. ACCORDING TO THE REPORT SHE HAD RECEIVED, THE DETENTION FACILITY WAS UNIMAGINABLE -- THE PRISONERS HAVE ALMOST NO CLOTHES, NO BLANKETS AND ARE NOT ABLE TO BATHE. DESPITE THE FACT THAT SHE KNOWS HER SON WAS HELD BY THE GOVERNMENT, SHE ONLY RECEIVES DENIALS.

6. IN RESPONSE TO ANOTHER QUESTION, THE MOTHERS STATED THAT

THEIR CHILDREN'S NAMES APPEARED ON THE RECENT LA PRENSA LIST OF 2,500 DISAPPEARED CASES. THEY ADDED THAT THEY HAVE PRESENTED TESTIMONIES TO THE MEDH AND TO THE PERMANENT ASSEMBLY. THEY HAVE FILED MANY HABEAS CORPUSES. THEY HAVE VISITED THE MONISTRY OF INTERIOR, AS WELL AS POLICE AND ARMY HEADQUARTERS, BUT NO ONE ACKNOWLEDGES THE DETENTION OF THEIR CHILDREN. THEY NOTED ALSO THAT THEIR SONS' CASES HAD BEEN INCLUDED IN THE RECENT HABEAS CORPUS PETITION TO THE SUPREME COURT. THE UNDER-SECRETARY INQUIRED ABOUT THE EFFECT OF A SUPREME COURT DECISION ON HABEAS CORPUS PROCEEDINGS. THE MOTHERS REPLIED THAT THE COURT'S DECISION WOULD HAVE NO EFFECT. HOWEVER, MRS. PARGAMENT NOTED THAT SEVERAL GRANDMOTHERS, WHOSE DAUGHTERS DISAPPEARED WHILE PREGNANT, CALLED ON THE PRESIDENT OF THE SUPREME COURT LAST WEEK. THE CHIEF

JUDGE WAS VERY MOVED BY THE VISIT AND REQUESTED THEM TO ARRANGE A MEETING WITH ALL THE 13 GRANDMOTHERS TO SEE IF JUDICIAL EFFORTS COULD BE MADE ON THEIR BEHALF. MRS. PARGAMENT CONTINUED THAT THERE IS INFORMATION THAT CHILDREN BORN TO DISAPPEARED MOTHERS HAVE BEEN GIVEN AWAY. THIS SHE DESCRIBED AS THE WORST VIOLATION COMMITTED BY THE GOVERNMENT. (NOTE: THE MOTHERS PRESENTED SECRETARY NEWSOM A LETTER AT THE CONCLUSION OF THE MEETING WHICH CONTAINED DETAILED INFORMATION REGARDING THE ABDUCTION OF THE 13 PREGNANT MOTHERS.) MR. NEWSOM INQUIRED WHETHER DISAPPEARANCES CONTINUE TO TAKE PLACE. THERE WERE A GENERAL AFFIRMATION THAT DISAPPEARANCES ARE CONTINUING.

7. PERMANENT ASSEMBLY FOR HUMAN RIGHTS:

DR. MIGNONE PRESENTED AN OVERVIEW OF THE ARGENTINE HUMAN RIGHTS SITUATION. HE SAID THAT BOTH THE ECUMENICAL MOVEMENT FOR HUMAN RIGHTS (MEDH) AND THE PERMANENT ASSEMBLY FOR HUMAN RIGHTS ARE DEDICATED TO RESOLVING THE HUMAN RIGHTS PROBLEMS IN ARGENTINA. THE MEDH IS AN ECUMENICAL ORGANIZATION OF CATHOLIC AND PROTESTANT CHURCHES AND HAS A RELIGIOUS BASE. THE PERMANENT ASSEMBLY IS ALSO MULTI-RELIGIOUS, BUT IT IS MORE OF AN INSTITUTION OF PERSONS, RATHER THAN ORGANIZATIONS.

CHARGES. THE ASSEMBLY'S CO-PRESIDENT ALFREDO BRAVO AND THE MEDH'S CO-PRESIDENT PEREZ ESQUIVEL DO NOT KNOW THE REASON FOR THEIR DETENTION.

8. DR. MIGNONE  
POINTED OUT THAT DISAPPEARANCES CONTINUE IN ARGENTINA ----  
IN THIS MONTH ALONE, THE  
ASSEMBLY HAS RECEIVED REPORTS OF SOME 40 CASES. HE  
NOTED THAT A LIST OF THESE CASES WAS GIVEN TO MR. HARRIS  
JUST BEFORE THE MEETING. DR. MIGNONE COMMENTED  
THAT THE MAY DISAPPEARANCES FOLLOW THE SAME PATTERN  
WE HAVE SEEN IN THE LAST TWO AND ONE-HALF YEARS,  
SHOWING THAT ILLEGAL PROCEDURES ARE  
BEING CONTINUED. DR. MIGNONE EMPHASIZED THAT THE CASES  
THE ASSEMBLY KNOWS ABOUT ARE ONLY A SMALL PERCENTAGE OF  
THE CASES THAT ACTUALLY OCCUR. ONLY THOSE WHO COME TO  
THE MEDH OR THE PERMANENT ASSEMBLY OFFICES HAVE THEIR  
CASES REPORTED. THERE IS GREAT FEAR AMONG FAMILIES IN  
REPORTING DISAPPEARANCE CASES. MOREOVER, THERE IS VERY  
LITTLE PUBLICITY GIVEN TO THE ACTIVITIES OF THE FEW  
HUMAN RIGHTS ORGANIZATIONS IN ARGENTINA. THERE IS  
STRONG SELF-CENSORSHIP IN THE ARGENTINE PRESS, WITH THE  
EXCEPTION OF THE BUENOS AIRES HERALD. THERE IS NO  
DISCUSSION AT ALL OF HUMAN RIGHTS PROBLEMS ON RADIO AND  
TELEVISION. PEOPLE LIVING IN THE INTERIOR, WHO HAVE HAD  
DISAPPEARANCES IN THEIR FAMILY, DO NOT HAVE THE MEANS  
OR IN MANY CASES THE RESOURCES TO CONTACT THESE  
ORGANIZATIONS.

9. IN RESPONSE TO A QUESTION REGARDING THE TYPES OF  
INDIVIDUALS DISAPPEARING, MR. MIGNONE SAID THAT THE  
SAME GENERAL PATTERN IS BEING FOLLOWED, ONLY PERHAPS  
MORE WORKERS ARE DISAPPEARING NOW THAN IN EARLIER TIMES.  
HE STRESSED THAT THE TOTAL NUMBER OF DISAPPEARANCES IS  
EXTREMELY LARGE. HE NOTED THAT THE HUMAN RIGHTS  
ORGANIZATIONS PUBLISHED A LIST IN LA PRENSA OF 2,500  
REPORTED NAMES; HOWEVER, FOR EACH NAME REPORTED THERE  
ARE 3, 4, 5 OR, IN HIS ESTIMATE, 10 CASES WHICH ARE NOT  
REPORTED. HE CONCLUDED THAT AT THE VERY MINIMUM THERE  
ARE BETWEEN 8 AND 9,000 DISAPPEARED PERSONS, BUT SAID  
THAT HIS PERSONAL ESTIMATION WAS THAT THE ACTUAL NUMBER  
IS IN THE NEIGHBORHOOD OF 25-30,000 PERSONS. MRS.  
BONAFINI INTERRUPTED TO NOTE THAT IN LA PLATA IT IS  
AGREED THAT AROUND 7,000 STUDENTS HAVE DISAPPEARED.

10. DR. MIGNONE CONTINUED, STATING THAT TO THE NUMBER OF DISAPPEARED MUST BE ADDED SOME 4,000 PERSONS DETAINED WITHOUT CHARGES UNDER THE PODER EJECUTIVO NACIONAL. MIGNONE COMMENTED THAT ALTHOUGH PRESIDENT VIDELA SAYS THERE ARE NO POLITICAL PRISONERS IN ARGENTINA, THOSE PERSONS HELD WITHOUT CHARGES CAN ONLY BE DESCRIBED AS POLITICAL PRISONERS. HE SAID THAT GOVERNMENT OFFICIALS, FOR EXAMPLE, IN THE CASES OF BRAVO AND PEREZ ESQUIVEL, ADMIT THAT NEITHER PERSON HAS BEEN INVOLVED WITH SUBVERSION. IN FACT, NEITHER HAS EVEN BEEN INTERROGATED WHILE IN DETENTION.

11. MIGNONE CONTINUED THAT TO HESE NUMBERS MUST ALSO BE ADDED THE 8 TO 10,000 PERSONS KILLED, WHOSE DEATHS ARE KNOWN. MIGNONE STATED THAT THERE ALSO MUST BE ADDED SOME THOUSANDS WHO HAVE BEEN TAKEN PRISONER, INTERROGATED, IN MANY CASES TORTURED, AND THEN RELEASED. DR. MIGNONE ESTIMATED THAT THERE HAVE BEEN IN THE NEIGHBORHOOD OF 50,000 PERSONS AFFECTED BY THE

ARGENTVNE ANTI-SUBVERSIVE EFFORT. HE NOTED THAT OF THIS TOTAL ONLY AROUND 1,000 PERSONS HAD BEEN LEGALLY PROCESSED, 500 PLUS IN THE CIVILIAN COURTS AND 300 PLUS IN THE MILITARY COURTS. IN RESPONSE TO A QUESTION, DR. MIGNONE REPLIED THAT THE CIVIL COURTS WERE OPEN AND DEFENSE LAWYERS WERE AVAILABLE; HOWEVER, HE NOTED THE MILITARY COURTS WERE CLOSED AND DEFENDANTS DID NOT HAVE THE RIGHT TO COUNSEL.

12. MR. NEWSOM INQUIRED WHETHER JUDGES WERE INTIMIDATED. THERE WAS A CONSENSUS THAT THE JUDGES IN THE CIVILIAN COURTS WERE NOT PRESENTLY INTIMIDATED. MR. NEWSOM

ASKED IF THERE WERE, IN FACT, ACQUITTALS IN THE CIVILIAN COURTS. BISHOP GATTINONI RESPONDED THAT THERE WERE CASES OF PERSONS BEING ACQUITTED OF CHARGES IN CIVILIAN COURTS; UNFORTUNATELY, IN SOME CASES WHERE THE PERSONS WERE RELEASED, THEY WERE KIDNAPPED AND DISAPPEARED. HE SAID THAT MORE FREQUENTLY PERSONS, UPON ACQUITTAL, WOULD BE PLACED UNDER THE PODER EJECUTIVO NACIONAL. BISHOP GATTINONI RELATED THAT SEVERAL PERSONS THIS YEAR HAD BEEN RELEASED FROM PRISON LATE AT NIGHT AND HAD THEN DISAPPEARED.

13. DR. MIGNONE PROCEEDED AND STATED THAT THE ROOTS OF THE HUMAN RIGHTS PROBLEM IN ARGENTINA RELATED TO THE DOCTRINE OF WAR WHICH THE MILITARY FORCES HAD ADOPTED IN 1975 TO FIGHT SUBVERSION. THIS DOCTRINE ALLOWED KIDNAPPING, TORTURE AND KILLING, WITHOUT ANY LIMITS BEING IMPOSED FROM ABOVE. FURTHERMORE, THE ARMED FORCES AS A MATTER OF POLICY DENIED SEIZURE OF ALL PERSONS. HE CONCLUDED THAT IN SUCH A SITUATION THERE IS NO POSSIBILITY OF RESPECT FOR THE LAW. THE JUDICIAL SYSTEM IS AT THE MARGIN OF ACTUAL DEVELOPMENTS IN ARGENTINA.

14. DR. MIGNONE CONTINUED THAT IT WAS RIDICULOUS TO

THINK THAT IN A WELL CONTROLLED DICTATORSHIP SUCH AS ARGENTINA THAT 10,000 TO 20,000 PERSONS COULD DISAPPEAR WITHOUT A TRACE. UNDER THESE CIRCUMSTANCES, THE COURT SYSTEM WAS POWERLESS TO PLAY A ROLE IN RESOLVING THIS PROBLEM. HE REFERRED TO A SUPREME COURT OPINION LAST YEAR WHICH HELD THAT THE COURTS HAD NO MEANS TO INVESTIGATE THESE REPORTED DISAPPEARANCES AS THE EXECUTIVE BRANCH DID NOT ITSELF INVESTIGATE THEM, NOR ANSWER JUDICIAL INQUIRIES.

15. DR. MIGNONE EMPHASIZED THAT IT IS IMPOSSIBLE THAT A MILITARY GOVERNMENT IN POWER FOR TWO YEARS CANNOT MAINTAIN CONTROL OVER ITS OWN TROOPS. HE SAID HE THOUGHT THE MILITARY WAS IN CONTROL OF ITS FORCES AND THEREFORE WAS RESPONSIBLE FOR THE DISAPPEARANCES. HE CHARACTERIZED THE CURRENT POLITICAL SITUATION AS ONE OF MILITARY FEUDALISM. DR. MIGNONE EMPHASIZED THAT THE SITUATION CONTINUES AS BEFORE; THE GOVERNMENT HAS ADOPTED NO MEASURES TO MODIFY THE SITUATION. BISHOP GATTINONI ADDED THAT THE HUMAN RIGHTS ORGANIZATIONS DO NOT WANT PROMISES SUCH AS THEY WERE GIVEN LAST YEAR. (NOTE: PROBABLE REFERENCE TO PRESIDENT VIDELA'S PEACE BY CHRISTMAS STATEMENTS MADE IN THE UNITED STATES.)

16. MEDH: MR. PASCALE EXPRESSED HIS APPRECIATION TO THE UNDER SECRETARY FOR COMING TO ARGENTINA. HE SAID THE MEDH, WHICH IS MADE UP OF PERSONS AND GROUPS EXPRESSING RELIGIOUS CONCERNS OVER THE HUMAN RIGHTS QUESTIONS HERE, GREATLY APPRECIATE THE U.S. GOVERNMENT'S EFFORTS TO RESOLVE THE COMPLICATED PROBLEM THAT DR. MIGNONE SO WELL EXPLAINED. HE ADDED THAT THE PROBLEM HERE IS VERY COMPLICATED AND PREDATES THIS GOVERNMENT. FURTHERMORE, HE NOTED THAT THE SCALE OF [REDACTED]

VIOLENCE HERE IS NON-LINEAR; IT IS A TWISTING SITUATION. HE SAID THAT THE CATHOLIC CHURCH IS WELL INFORMED REGARDING HUMAN RIGHTS PROBLEMS -- THE CHURCH ITSELF HAS HAD 17 PRIESTS AFFECTED PLUS KIDNAPPING OF THE FRENCH NUNS AND OTHER LAY CHURCH LEADERS KIDNAPPED. MANY FAMILIES CAUGHT UP IN THESE EVENTS PREFER TO EXPRESS THEIR PROBLEMS TO THE CHURCH. MR. PASCALE SAID THAT EACH DAY FROM ALL SECTORS OF ARGENTINE SOCIETY, PEOPLE CONTINUE TO COME TO THE MEDH OFFICES TO REPORT DISAPPEARANCES. SINCE THE LA PRENSA 2500 LIST WAS PUBLISHED THE NUMBER OF PERSONS COMING EACH DAY HAS DOUBLED. HE SAID THE MEDH WISHES TO BE VERY STRICT IN ITS STATEMENTS REGARDING THE NUMBER OF DISAPPEARANCES, BUT IT CAN SAY DEFINITELY THAT MANY NEW CASES ARE ARRIVING DAILY. MR. PASCALE NOTED THAT THERE ARE QUALITATIVE DIFFERENCES AS WELL WHICH ARE SHOWING UP. FOR EXAMPLE, SOME WIVES OF SENIOR MILITARY AND POLICE OFFICERS HAVE COME RECENTLY TO REPORT THE DISAPPEARANCES OF THEIR SONS. THIS SHOWS HOW COMPLICATED THE SITUATION IS IN ARGENTINA. THE POWER DOES NOT BELONG TO

17. QUESTIONS AND ANSWERS -----

MR. NEWSOM INQUIRED WHAT CHANGES THE GROUPS FORESAW AFTER THE AUGUST 1 POLITICAL ADJUSTMENTS. BISHOP GATTINONI RESPONDED THAT THE REAL POWERS OF THE PRESIDENT HAVE STILL NOT BEEN DECIDED. WE HOPE, HE SAID THAT THINGS WILL IMPROVE, BUT UNFORTUNATELY IN THE PAST THE PROBLEMS HAVE BEEN DEALT WITH BY PROMISES WHICH WERE NOT FULFILLED.

18. THE UNDER SECRETARY COMMENTED THAT BECAUSE OF PRESENT ARGENTINE CONDITIONS, THE UNITED STATES GOVERNMENT HAS SUSPENDED OFFICIAL TRANS-ACTIONS WITH THE GOVERNMENT OF ARGENTINA. HE WONDERED WHETHER, IN THE VIEW OF THE GROUP,

THESE HAD BEEN EFFECTIVE. DR. MIGNONE REPLIED THAT THE HUMAN RIGHTS ORGANIZATIONS FIRMLY SUPPORTED THE U.S. POLICY. HE ADDED THAT AID TO "SUCH AN INHUMAN GOVERNMENT" SHOULD BE DENIED ALL TOGETHER. FATHER GIUSTOZZI COMMENTED THAT THE SOLUTIONS TO THE HUMAN RIGHTS PROBLEMS HERE MUST COME INTERNALLY, BUT THAT OUTSIDE HELP WAS ALSO NEEDED. 19. MR. NEWSOM POSED THE PROBLEM THAT AS MOVES  
WERE MADE TO ISOLATE ARGENTINA THERE WAS A  
TENDENCY FOR SOME SECTORS TO MOVE TOWARDS  
GREATER NATIONALISM. THIS ILLUSTRATES THE  
DILEMMA IN TRYING TO ACHIEVE OBJECTIVES IN OTHER  
SOCIETIES. THE UNITED STATES CAN ISOLATE  
ARGENTINA OR CAN SEEK TO DETERMINE AREAS OF

ORGANIZATIONS REPRESENTED HERE ARE OPEN AND THEIR ACTIVITIES PUBLIC. MRS. PARGAMENT ADDED THAT WHEN THE MOTHERS MEET WITH GOVERNMENT OFFICIALS THEY SAY MANY HARDED THINGS THAN HAVE BEEN SAID THIS AFTERNOON.

21. MR. NEWSOM SAID THAT AS AN INDIVIDUAL GOVERNMENT, THE UNITED STATES CANNOT INQUIRE FULLY INTO THE SITUATION IN OTHER COUNTRIES. OFTEN, HE NOTED, WE SEEK TO ENCOURAGE GOVERNMENTS TO INVITE INTERNATIONAL ORGANIZATIONS SUCH AS THE INTERNATIONAL COMMISSION OF JURISTS OR THE INTER-AMERICAN HUMAN RIGHTS COMMISSION TO VISIT COUNTRIES. HE QUERIED WHETHER THE GROUP CONSIDERS THAT SUCH VISITS ARE HELPFUL. RABBI GRAETZ RESPONDED THAT SUCH VISITS WOULD CERTAINLY BE HELPFUL AND ENCOURAGING; BUT IT TERMS OF CONCRETE RESULTS, HE OPINED THAT THEY WERE OF LITTLE HELP. MR. PASCALE POINTED OUT SOME PROBLEMS WITH INTERNATIONAL HUMAN RIGHTS ORGANIZATIONS.

HE NOTED THAT THE INTERNATIONAL COMMISSION OF JURISTS AND THE WORLD COUNCIL OF CHURCHES, AND ESPECIALLY THE LATTER'S PRESIDENT, CHRIS HARPER, HAD RECENTLY BEEN ATTACKED IN THE ARGENTINE PRESS AS BEING ANTI-ARGENTINE. RECENTLY, THE THREE ORGANIZATIONS WHICH PUT TOGETHER THE LA PRENSA ADVERTISEMENT WERE BITTERLY ATTACKED. HE NOTED THAT HUMAN RIGHTS GROUPS MUST BE VERY CAREFUL WITH RESPECT TO THEIR INTERNATIONAL RELATIONS AS THEY DO NOT WISH TO FALL INTO A TRAP. FATHER GIUSTOZZI ADDED THAT AMNESTY INTERNATIONAL, WHICH VISITED ARGENTINA IN 1977 HAD ALSO BEEN SEVERELY ATTACKED BY THE ARGENTINE PRESS. DR. MIGNONE SUGGESTED THAT THE INTER-AMERICAN HUMAN RIGHTS COMMISSION VISIT WAS VERY IMPORTANT. HOWEVER, HE NOTED, THAT DESPITE THE PUBLIC ANNOUNCEMENT THAT THE INTER-AMERICAN HUMAN RIGHTS COMMISSION WISHED TO VISIT ARGENTINA, THE GOVERNMENT HAD NOT INVITED THEM.

22. BISHOP GATTINONI AFFIRMED THAT UNITED STATES HELP WAS NEEDED IN THE RIGHT OF OPTION PROGRAM. HE SAID THAT THERE HAD BEEN GREAT DIFFICULTY

IN RECEIVING RIGHT OF OPTION CERTIFICATES FROM THE OTHER EMBASSIES AND THAT A UNITED STATES RESETTLEMENT PROGRAM WOULD MAKE A SIGNIFICANT CONTRIBUTION TO RESOLVING THE DETAINEES PROBLEM. MR.
